According to the 2017-2018 Best Hospitals ranking from *U.S. News & World Report*, 10 medical specialties at UAB Hospital are ranked in the top 50 in the nation, four others including gastroenterology and GI surgery are listed as “high-performing.”

The highest-ranked specialties included nephrology, urology, diabetes and endocrinology.

Eight UAB programs moved up in the rankings. Geriatrics earned a top 50 ranking for the first time, while urology, pulmonology, cardiology, diabetes and endocrinology had the largest jumps in the rankings.

The magazine also lauds UAB for high performance in seven adult procedures including colon cancer surgery.

FDA approves Humira biosimilar Cyltezo

The FDA has approved a second biosimilar to Humira. Cyltezo is an anti-TNF drug delivered by subcutaneous injection for the treatment of moderate to severe rheumatoid arthritis, psoriatic arthritis, ankylosing spondylitis, moderate to severe Crohn's disease, moderate to severe ulcerative colitis, and moderate to severe chronic plaque psoriasis in adults, and moderate to severe polyarticular juvenile idiopathic arthritis in children aged 4 years and older.

"It is not known if Cyltezo is effective

in people who stopped responding to or could not tolerate TNF-blocker medicines," according to the FDA medication guide.

The prescribing information includes warnings about serious infections and malignancy risks, including lymphoma, associated with the drug. The most common adverse reactions included infections, injection site reactions, headache and rash.

This is the second biosimilar to Humira approved by the FDA, the first being Amjevita, approved in September 2016.

The approval is based on analytical, pharmacological, non-clinical and clinical development studies showing Cyltezo is biosimilar to Humira. It is not yet commercially available and the company is engaged in patent litigation with AbbVie, according to the press release.

The company added that it will also seek approval for an auto-injector of Cyltezo, and expects the European Medicines Agency to issue an opinion on the marketing authorization application this year. 

Physician groups call on CMS to revise reimbursement, payment policies for biosimilars

CMS recently closed its comment period for the Revisions to Payment Policies under the Physician Fee Schedule and Other Revisions to Part B for CY 2018 proposed rule. The Biosimilars Council and several physician groups submitted comments prior to the closing period and urged CMS to revise the reimbursement policy for biosimilars in Medicare Part B and to revise the current payment policy for biosimilars.

According to a release, the Biosimilars Council, a division of the Association of Accessible Medicines, noted CMS should provide unique reimbursement codes for all non-interchangeable biosimilars instead of a single payment code. This change could create substantial savings for patients and health care payers, as well as expand patient access to biosimilar medicines, the release noted.

In a second release, the Biologics Prescribers Collaborative – along with the Alliance for Patient Access, American Association of Clinical Endocrinologists, American College of Rheumatology, American Gastroenterological Association and the Coalition of State Rheumatology Organizations – urged CMS to adopt unique Healthcare Common Procedure Coding System billing codes for biosimilars medicines instead of taking a


generic approach. These physician groups noted that use of different reimbursement levels for different biosimilars will not only promote competition, but will help create a more robust market while protecting patient safety.

The comments submitted by the Biologics Prescribers Collaborative asked CMS to consider the following:

- Biosimilars are not generic drugs and CMS should not treat these as such;
- A single J-code policy does not properly recognize interchangeability;
- Grouping biosimilars of the same reference product into one J-code could create barriers for physicians to choose the most appropriate biosimilar;
- Blended reimbursement may lead to

inappropriate non-medical switching; and

- Single J-codes could reduce investment in the biosimilars market and stifle therapeutic choices.

"The current reimbursement landscape is extremely complex. Unique J-codes for biosimilars help clarify for physicians that while 'highly similar,' biosimilars of the same reference product will likely still have product differences that should be considered in clinical decision-making," Dennis R. Cryer, MD, co-convenor of the Biologics Prescribers Collaborative, said in a release. "Grouping biosimilars in one blended reimbursement rate prioritizes price above all other features and has the potential to undermine patient care and safety."
